WHEREAS,

The administration of CUNY Law has failed to ensure that the design of 2 Court Square is accessible to all students;

This lack of accessibility creates a school environment that favors groups of some students over others;

CUNY Law is required to comply with and has violated the Americans With Disabilities Act (ADA) by

failing to ensure that the building construction was ADA compliant (e.g., non-functional accessible front doors; interior doors set at non-compliant levels of weight/pressure required to open) and failing to enact appropriate educational access plans for students with disabilities (e.g., remote captioning assistance; appropriate class note-taking assistance; lighting and microphone usage);

Be It Resolved That:

- Student Government calls on CUNY School of Law Administration, Faculty, Students, and Staff to collectively work to advance CUNY School of Law's dual mission of training public interest lawyers and increasing access to the legal profession

- To that end, Student Government works in solidarity with those whose access to CUNY School of Law is most restricted by CUNY Law's institutional policies, practices, and physical limitations and by oppressive social norms to reduce or eliminate barriers to access within CUNY School of Law.

This work to increase access to CUNY Law includes, but is not limited to:

- Eliminating barriers to access experienced by people with disabilities within the CUNY community, beyond minimal compliance with ADA requirements (e.g., being mindful of disabilities when creating room or office assignments for students and faculty, particularly concerning time scheduled between classes and proximity and design of classrooms; building in structures of accountability, awareness, and support among administration, faculty, staff, and students regarding educational access for students with disabilities; promoting institutional programming within the CUNY community regarding being effective allies to students, faculty, staff, administrators, and guests with disabilities)

- This includes ensuring that an ADA compliance officer evaluates 2 Court Square and CUNY Law's educational accessibility plans and that CUNY Law take immediate steps to ensure complete compliance with the ADA as required by law;

- Eliminating barriers to access to the building experienced by people who, for various reasons, do not have state-issued personal identification (e.g., people whose IDs are not affirming of their gender identities, people who are undocumented immigrants)

- Eliminating barriers to access to education that may be experienced by people who are current or former survivors of trauma (e.g., increasing awareness of ways to minimize the potentially harmful effects of reading or discussing cases where trauma is addressed; increasing awareness among students, faculty, staff, and administrators of ways to be more effective allies to trauma survivors; effectively communicating protocols for institutional responses to CUNY community members with ongoing safety concerns).

- Eliminating barriers to access created by various forms of institutional oppression (e.g., supporting anti-oppression programming for students, faculty, staff, and administrators to give people tools to address and resist racism, sexism, homophobia, transphobia, ablism, xenophobia, classism, and other forms of oppression).

Student Government Orientation

...or How I Learned How to Stop Worrying and Love Procedural Limitations

WHAT IS STUDENT GOVERNMENT?

The Student Government (SG) acts as an independent mechanism for unified student action and a voice for academic, government, political and social concerns. The general purpose of SG is to serve as a focal point for organizing the collective power and interests of the entire CUNY Law student body – over 400 students, all with a demonstrated commitment to justice and the service of human needs – in order to address the issues that matter most to students. SG bears a general responsibility to deliberate and act upon matters of obvious serious interest to the student community; it also has a responsibility to set an agenda which is at once proactive and responsive to student interests.

HOW DOES SG WORK?

- SG meets weekly or biweekly to talk about and do things related to student needs
- We can follow one of two categorical decision-making models:
 1. Robert's Rules Parliamentary Decision-Making; OR
 2. Consensus Model ("majority" decision-making with notable reservations on those who agree to disagree)
- SG hosts at least one Deans Forum and one Student Forum per year, preferably one or more of each per semester. The purpose of these forums is to provide a space for students to speak candidly with one another about issues faced by community members and the student body as a whole, and to have the direct attention of the deans to communicate these issues.
- SG has helped coordinate staff appreciation days, which occur once a semester.
- SG also organizes and hosts Community Day, held at the end of the second semester
- Sg hosts the student-only clinic fair
- SG drafts and adopts resolutions and creates petitions that help to hold the faculty and the administration accountable. The specific nature of these projects depend on the concerns that are brought to SG by the student body.
- SG members also serve on a number of important internal and external committees
